This Memorandum of Understanding (hereinafter referred to as "MOU") is made and entered into on, 07 November 2017, by and between:

**APPASAHEB BIRNALE COLLEGE OF PHARMACY, SANGLI**, a college at South Shivajinagar, Sangli-Miraj Road, Sangli-416-416, Maharashtra, India (hereinafter referred to as, the "**COLLEGE or First Party**"),

AND

**SAMPURNA JEEVAN PHARMACHEM PVT LTD.**, a pharmaceutical company located at 104, Sector F4th Phase, Parvati Industrial Area, Yadrav- 416145, Maharashtra, India (hereinafter referred to as the "**COMPANY or Second Party**").

WHEREAS, the **COLLEGE** is a recognised educational institution that offers courses in pharmacy and related fields, and the **COMPANY** is a chemical industry engaged in the manufacturing and distribution of various chemicals and pharmaceuticals;

WHEREAS, the parties desire to collaborate and cooperate in the area of research and development of pharmaceutical products and related fields and to promote academic and industrial exchanges in these fields,

NOW, THEREFORE, the **COLLEGE** and the **COMPANY** agree to the following terms and conditions:

**OBJECTIVES:**

The objective of this MOU is to establish a framework for cooperation and collaboration between the **COLLEGE** and the **COMPANY** for promoting academic and research activities in the field of pharmaceuticals, including but not limited to:

- a) Internships, training programmes, and industrial visits for students
- b) Continuing education and professional development programmes for faculties
- c) Joint conferences, seminars, and other educational activities
- d) Research and development of new pharmaceutical products and technologies;
- e) Exchange of scientific and technical knowledge and expertise;



## MODE OF COOPERATION:

The mode of cooperation between the COLLEGE and COMPANY will be as follows,

- 1. Internship and training Program:** The COMPANY shall provide opportunities for the students of the COLLEGE to undertake internships, in-plant training, and industrial visits at the COMPANY to gain practical knowledge and skills in the field of pharmaceuticals.
- 2. Continuing education and professional development programs:** The COMPANY shall provide training and development opportunities to the faculty members and students of the COLLEGE on the latest trends and advancements in the COMPANY.
- 3. Joint conferences, seminars, and other educational activities:** The COLLEGE and the COMPANY will jointly organize workshops, seminars, and conferences in the field of pharmaceuticals to exchange their knowledge, expertise, and research findings and to promote collaboration with the industry.
- 4. Research and development:** The COLLEGE and the COMPANY will establish joint research projects in the field of pharmaceuticals, in which they will jointly conduct research and development activities. Both the parties will allow to use their research facilities and equipment's, as well as necessary personnel.
- 5. Exchange of scientific and technical knowledge and expertise:** The COLLEGE and the COMPANY will exchange scientific and technical information, research findings, and expertise in the field of pharmaceuticals.

## FINANCIAL ARRANGEMENTS:

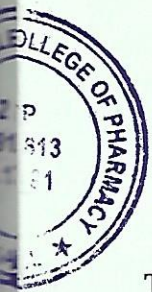
The financial arrangements between the COLLEGE and the COMPANY will be as follows:

The COLLEGE and the COMPANY will share the costs of joint research projects and joint workshops, seminars, and conferences in accordance with the agreement reached between them. Each party will bear its own costs related to the exchange of faculty members, researchers, and students. The COLLEGE and the COMPANY will share the costs of joint publications in accordance with the agreement reached between them.

## TERM:

This MOU shall remain in effect for a period of five (5) years from the date of signing, unless terminated earlier by mutual agreement of both parties.



**TERMINATION:**

This MOU may be terminated by either party by giving a written notice of 30 days to the other party.

**MODIFICATION:**

This MOU may be modified or amended by mutual agreement of the parties in writing.

**INTELLECTUAL PROPERTY RIGHTS:**

Any intellectual property generated through the joint research projects shall be jointly owned by the COLLEGE and the COMPANY and shall be subject to the mutual agreement and approval of both parties.

**CONFIDENTIALITY**

The COLLEGE and the COMPANY agree to keep confidential all information and data exchanged between them, whether it be scientific, technical, or business related, and to use such information and data only for the purposes of the joint research projects and other collaborative activities described in this MOU.

**CERTIFICATION**

Students who are successful in the assessment conducted by the COMPANY shall be awarded with a certificate post completion of the training, internship program.

**GOVERNING LAW AND DISPUTE RESOLUTION:**


