Whereas ABCP & MDS, (here after called parties) desire to carry out programmes for promoting Community Pharmacy-Academic interaction, herein referred to as "programme", jointly with the diligence and efficiency as desired with this MoU in conformity with appropriate administrative and educational practices and implement all such plans and activities and reforms for the programme.

Whereas the ABCP & MDS agree to enter into Community Pharmacy-academic interaction programmes, and both the parties agree to enter into an MoU with the terms as follows.

### **OBJECTIVES OF COMMUNITY PHARMACY ACADEMIC INTERACTION PROGRAMME**

The major objectives of for which the parties associate with each other are:

- a. To effectively share the facilities and expertise for improving the capabilities for advanced education and research.

- b. To facilitate academic interactions among employees of both institutes.
- c. Increase the relevance of the academic research and consultancy in the research and product development initiatives.
- d. Collaborate to share and exchange information between both parties for mutual benefit and knowledge enhancement.
- e. To provide opportunity for students from undergraduate and graduate ABCP & MDS to undertake Community Pharmacist training for mutual benefits.
- g. To encourage the training of employee of ABCP in continuing Education activities, Skill development activities.

**THE PROGRAMME**

This MOU is to formalize joint programme activities that will help ABCP to enhance its educational capabilities, and MDS in achieving its business objectives.

The following activities are indicative of the types contemplated through this joint program:

**JOINT PROJECTS**

Every year 10 Students from ABCP will participate in Community Pharmacist Training at MDS.

**STUDENT INTERNSHIPS AND EMPLOYMENT**

Students will be encouraged to take advantage of the opportunities that exist at MDS for employment.

Participation in programs that allow students to gain valuable experience & training as interns will be encouraged. However MDS will have no obligation to hire the student interns from ABCP.



## **FINANCE**

Regarding the financial arrangements during the Community Pharmacist Training no remuneration will be given to trainee student.

However if that trainee student wish to continue as employee of MDS then he is liable to get salary decided by MDS.


## **DURATION**
