This Memorandum of Understanding (here after referred to as MoU) is made on the 24 December 2018 between Appasaheb Birnale College of Pharmacy (Diploma), Sangli-416 416 (here after referred to as ABCP) one part and Vasantdada Patil Ayurvedic Medical college Hospital, Sangli. 416416 (here after referred to as VPAMCH) on the other part as partners for promoting the Hospital Pharmacy-Academic interaction activities and to help to achieve academic excellence of ABCP & VPAMCH.

Whereas ABCP & VPAMCH, (here after called parties) desire to carry out programmes for promoting Hospital Pharmacy-Academic interaction, herein referred to as "programme", jointly with the diligence and efficiency as desired with this MoU in conformity with appropriate administrative and educational practices and implement all such plans and activities and reforms for the programme.

Whereas the ABCP & VPAMCH agree to enter into Hospital Pharmacy-academic interaction programmes, and both the parties agree to enter into an MoU with the terms as follows.

OBJECTIVES OF HOSPITAL PHARMACY ACADEMIC INTERACTION PROGRAMME

The major objectives of for which the parties associate with each other are:

a. To effectively share the facilities and expertise for improving the capabilities for advanced education and research.

- b. To facilitate academic interactions among employees of both institutes.
- c. Increase the relevance of the academic research and consultancy in the research and product development initiatives.
- d. Collaborate to share and exchange information between both parties for mutual benefit and knowledge enhancement.
- e. To provide opportunity for students from undergraduate and graduate ABCP & VPAMCH to undertake Hospital Pharmacist training for mutual benefits.
- g. To encourage the training of employee of ABCP in continuing Education activities, Skill development activities.

THE PROGRAMME

This MOU is to formalize joint programmme activities that will help ABCP to enhance its educational capabilities, and VPAMCH in achieving its business objectives.

The following activities are indicative of the types contemplated through this joint program:

JOINT PROJECTS

Every year 10 Students from ABCP will participate in Hospital Pharmacist Training at VPAMCH.

STUDENT INTERNSHIPS AND EMPLOYMENT

Students will be encouraged to take advantage of the opportunities that exist at VPAMCH for employment.

Participation in programs that allow students to gain valuable experience & training as interns will be encouraged. However VPAMCH will have no obligation to hire the student interns from ABCP.

FINANCE

Regarding the financial arrangements during the Hospital Pharmacist Training no remuneration will be given to trainee student.

However if that trainee student wish to continue as employee of VPAMCH then he is liable to get salary decided by VPAMCH.

DURATION

This MoU will be active for a period of five years from the date of this MoU. It will be extended for further period by mutual consent.

TERMINATION

Either party has the right to terminate this MoU by giving ninety days written notice to the other party.
